At ILI, sustainability is central to what we do. Our commitment to continuous improvement in sustainable operations reduces our company's environmental impact. We take great effort to increase awareness about environmental issues within our industry and help create a more sustainable built environment.

LEED MR Credit 2 – Building Product Disclosure and Optimization – Environmental Product Declarations

Product-specific Type III Environmental Product Declarations (EPDs) are available for our louvers & equipment screens and sunshade product lines. Our EPDs have been verified through NSF and are publically available in the NSF Certified Products and Systems database. Louvers and equipment screens are published in the Roof and Wall Panels product category at <https://info.nsf.org/Certified/Sustain/ProdCert/EPD10628.pdf>, sunshades are published in the Sun Protection System category at <https://info.nsf.org/Certified/Sustain/ProdCert/EPD10629.pdf>. These EPDs provide a value of 1.5 products for the purposes of credit achievement calculation.

LEED MR Credit 3 – Building Product Disclosure and Optimization, Sourcing of Raw Materials

ILI has several aluminum extruder partners. Although each uses pre-consumer and post-consumer content, the content percentage varies by supplier and by profile. ILI can provide specific recycled content information at the time of quote for standard extrusions and at the time of order for custom extrusions. Information is self-reported and is not third party verified at this time.

LEED MR Credit 4 – Building Product Disclosure and Optimization – Material Ingredients

ILI discloses material content to 100ppm on a product level in nested format through third-party verified Health Product Declarations (HPDs). These are available to the public in the HPD Collaborative's public repository at <http://www.hpd-collaborative.org/hpd-public-repository/>. We use Valspar's Fluropon Pure formulation for all of our standard and most custom colors, ensuring that our finishes do not contain any Living Building Challenge Red List chemicals. We have published third party verified ILFI Declare labels that are available below and at <https://access.living-future.org/declare-products>. Both our HPDs and our Declare labels are third party verified. HPDs that include the verification of content inventory are worth 1.5 products for credit achievement calculations.

ILI is among the first manufacturers to have Petal Certification through ILFI's Living Product Challenge and is the first manufacturer in the United States to earn ILFI's JUST Label. Our commitment goes beyond our own operations and providing products for green building projects. We support the efforts of organizations that promote sustainability and environmental awareness throughout the industry. We support the U.S. Green Building Council (USGBC) and the Minnesota chapter of the USGBC, the Health Product Declaration Collaborative (HPDC), and ILFI through sponsorships, leadership roles, and volunteer support.
